## LITTLE ASHFORD PRESCHOOL

### 2022 OPERATING POLICIES, PAYMENT OPTIONS AND FEES

#### *Notice period*

Before withdrawing the child from the school, a parent is required to give a term's notice in writing to the Principal and the Accounts department, before the first day of the term at the end of which such withdrawal is to take place.

If the parent fails to give such notice, the parent shall be liable for a cancellation fee equivalent to two (2) months' tuition fee.

#### *Operating Hours*

The school will operate from 5 January to 30 November 2022, with no school holidays closure (except for the day prior to the beginning of a new school term - our preparation day). Holiday Club fees are included in your fees, except for December Club. Programme details in this regard will be announced in late 2022.

An academic year planner will be available to you on our website soon. Check from time to time.

Our closing time is 17:30. A late collection fee is levied for every 15 minutes late after 17:30. This fee is charged within the first minute of the 15 minute window and will NOT be *pro rata*. Our staff need to get home safely.

#### *Absenteeism and Lockdowns*

No fee rebate will be granted if the child is absent for any part of any term owing to illness, lockdowns or otherwise.

### Payment Options

There are three payment options (all further explained in *step 2* [here](#) and all require a [debit order mandate](#) on file):

- **Annually:**
  - If paid on or before 30 September 2021, a 9% discount will apply;
  - If paid on or before 30 November 2021, a 7% discount will apply; and
  - if paid on or before 31 December 2021, a 5.5 % discount will apply.
  - Payment may only be made via EFT (no cash/credit cards).
- **Termly:** 3 times a year, 2 months before our invoicing terms starting on 1 January (due by 1 November of the previous year, includes annual stationery levy); 1 May (due by 1 March) and 1 September 2022 (due by 1 July). This option offers a discount if settled in full via lump sum using EFT (no cash/credit cards are accepted). The discount will be reversed if the full term fee is NOT settled in full before the above respective dates - this is not negotiable.
- **Monthly:** fees are payable 2 months in advance, over 11 months (from November to September) by way of [debit order](#) ONLY. EFT is NOT acceptable for monthly payments. Please ensure your completed [debit order mandate](#) is submitted, using our highly secure and industry-leading Netchash collection platform. Our Accounts team will be able to assist you with this requirement.

For as long as two or more siblings attend Little Ashford, a discount will be applied to the tuition fee of the second and subsequent siblings only.

The Annual Stationery Levy is included in your first invoice upon enrolment. Every subsequent January invoice issued, for each year your child is enrolled with us will include this levy. Further detail about this critical levy is included in our Fees Schedule table shared in this communication.
